

### **Rules and Policies**

- 1. You must be 13 by the date of your audition, and no older than 19 years of age at the time of the final performance. No exceptions will be made.
  - a. Those selected to perform under the age of 18, must obtain written consent from a parent or legal guardian prior to the performance.
  - b. Media Consent must be signed by a parent or legal guardian, if under the age of 18, or participant if older than 18 years of age. This must be returned by the first rehearsal.
  - c. Completed and signed consent forms must be returned by the Company Meeting. NO EXCEPTIONS!
  - d. Failure to obtain these consents will result in loss of the opportunity to perform in United Teens Talent.
- 2. Acts should be no longer than four minutes.
- 3. Only acts auditioned in their entirety will be considered for participation. This includes both those performing and the act itself.
- 4. AUDITION FORM **must** be filled out in order to participate
- 5. In order to be eligible for the final show, you must be available for all two weeks of rehearsals and the opening and closing number. Please review these dates and indicate those for which there are conflicts by circling that date on this form.
- 6. Music that contains profanity or inappropriate lyrics is not allowed.
  - a. The Arts Council of Greater Kalamazoo, and its agents, reserves the right to determine appropriate content.
  - b. Music deemed inappropriate will not be allowed, some music may be appropriate if edited.
  - c. United Teens Talents will decide what music and editing are appropriate.
- 7. Inappropriate dance moves will not be allowed.
  - a. You will be notified if your dance moves are inappropriate and you will have until the following rehearsal to change those specific moves.
- 8. We value respect for all coaches and participants. Disrespectful comments to others and about others are not permitted.
- 9. Everyone must stay in their seat during rehearsals.
- 10. Each participant will be expected to perform in two group numbers, and your solo or group act.
- 11. Once you have been cast and your number has been approved you can not change it without prior approval of the show director.
- 12. If you have been dismissed you may not attend rehearsals (you may attend final show).
- 13. **ALCOHOL, INHALANTS, AND DRUG ABUSE** Students who unlawfully possess, use or distribute alcohol, inhalants and/or illicit drugs on premises or at UTT activity or event will be subject to discipline up to and including expulsion and referral to the police for prosecution.
- 14. **WEAPONS** The Arts Council of Greater Kalamazoo, and its agents, is committed to providing a safe and nurturing environment at United Teens Talent. The presence of weapons on property or at any UTT sponsored activity threatens this commitment. Therefore, the possession or use of any type of weapon on property or at UTT sponsored activities is strictly forbidden, unless the weapon is in the possession of a law enforcement agent. A student who possesses a firearm on property, subject to discipline up to and including expulsion and referral to the police for prosecution.
- 15. **ANTI-HARASSMENT/ ANTI-VIOLENCE POLICY** It is the policy of the Arts Council of Greater Kalamazoo, and its agents, to maintain learning and working environments that are free from all forms of harassment, including bullying, intimidation, sexual harassment, physical assault and threats of imminent harm. No staff member or

student of the UTT program shall be subjected to any form of harassment or intimidation. No staff member or student of the UTT program shall be subjected to physical assault or threats of imminent harm by another. A student who fails to comply with this policy will be subject to discipline up to and including expulsion and referral to the police for prosecution.
